

**FACTS****WHAT DOES Bank of Bozeman  
DO WITH YOUR PERSONAL INFORMATION?**

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>■ Social Security number and <b>Income</b></li> <li>■ <b>Account Balance</b> and <b>Transaction History</b></li> <li>■ <b>Credit History</b> and <b>Credit Scores</b></li> </ul> <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
<b>How?</b>	All financial companies need to share <b>customers'</b> personal information to run their everyday business. In the section below, we list the reasons financial companies can share their <b>customers'</b> personal information; the reasons <b>Bank of Bozeman</b> chooses to share; and whether you can limit this sharing.

<b>For our everyday business purposes—</b> such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus	Yes	No

## What we do

How does **Bank of Bozeman** protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Employees are made aware of the Bank's privacy policy and trained in procedures that maintain confidentiality.

How does **Bank of Bozeman** collect my personal information?

We collect your personal information, for example, when you

- Open an account                      or Apply for a loan
- Make deposits                         or Withdrawals
- Pay your bills

We also collect your personal information from others, such as credit bureaus, affiliates or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

## Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Bank of Bozeman does not share with our affiliates.*

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Bank of Bozeman does not share with non-affiliates so they can market to you.*

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Bank of Bozeman does not participate in joint marketing.*

## Other important information

Bank of Bozeman maintains physical, electronic and procedural safeguards that comply with federal standards to guard your non- public personal information.

Safekeeping of our customer information is a high priority, therefore, we will continue to maintain high standards necessary to ensure that your information is kept private and secure at all times.
